Hosted by Aarupadai Veedu Institute of Technology, Vinayaka Mission's Chennai Campus

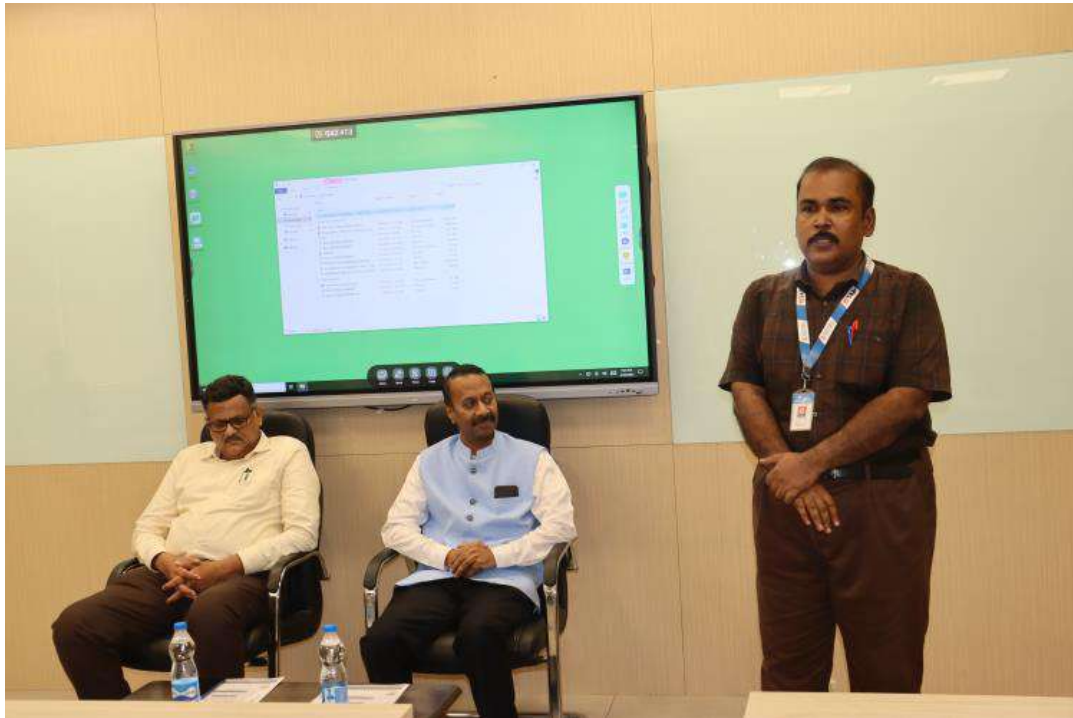

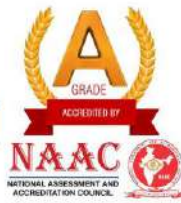
Inaugural Address & Session by Resource Person


